CONSTRUCTION UPDATE
AUGUST 7, 2026

Gauga County Engineer, Andrew Haupt, PE, PS, has announced the start/continuance of construction on the following projects in Gauga County.

- ***Bainbridge Township, Pettibone Road:*** Work has commenced on The Replacement of the Pettibone Road Bridge between Gauga Lake Road and Brewster Road. The roadway is closed at the bridge and a detour posted, expect delays.
- ***Chardon Township, Various Roads:*** The Reconstruction and Asphalt Resurfacing of Various Roads including Wintergreen Drive, Crestridge Drive, North & South Wintergreen Drive, Woodview Drive and Hawthorne Drive will begin on/about August 17th and last approximately 42 days. Traffic will be maintained, expect delays.
- ***Chardon Township and Munson Township, Thwing Road and Auburn Road:*** Work has commenced on The Asphalt Resurfacing of Auburn Road from Thwing Road to U.S. 6 and Thwing Road from the Lake County Line to Auburn Road. Thwing Road is closed to traffic from the Lake County Line to Fowlers Mill Rd with a detour posted until August 14 for the re-profiling of vertical curves and superelevation cross slope adjustments. Residential access will be maintained at all times. Otherwise, traffic is being maintained, expect delays.
- ***Middlefield Township, Adams Road and Swine Creek Road:*** Work has commenced on The Asphalt Resurfacing and Chip Seal of Adams Road and Swine Creek Road from Adams Road to 16900 Swine Creek Road. Asphalt was installed on both roads, and the project will have a multi-week pause before the contractor returns to Chip Seal over top the newly installed asphalt. Traffic is being maintained, expect delays.
- ***Montville Township and Thompson Township, Burrows Road:*** Work has commenced on The Cement Stabilization and Chip Seal of Burrows Road from SR528 to The Ashtabula County Line. The road will be closed intermittently throughout the project with traffic restored by the end of each day. Residential access will be maintained at all times. Otherwise, traffic is being maintained, expect delays.
- ***Munson Township, Nicoles way and Sutton Place:*** The Reconstruction of Nicoles Way and Sutton Place will begin on/about August 10th and last approximately 42 days. Traffic will be maintained, expect delays.
- ***Munson Township & Newbury Township, Bass Lake Road:*** Work has commenced on The Asphalt Resurfacing of Bass Lake Road from Butternut Road to S.R. 44 (South Street). Traffic is being maintained, expect delays.
- ***Newbury Township, Various Roads:*** Work has commenced on The Chip and Seal of various roads including Pond Road, Lela Lane, Dianne Drive and Linda Drive. Traffic is being maintained, expect delays.
- ***Newbury Township, Park View Drive:*** Work has commenced on The Asphalt Resurfacing of Park View Drive. Traffic is being maintained, expect delays.
- ***Parkman Township, Hosmer Road:*** The Chip and Seal of Hosmer Road from Nash Road to Old State Road will begin on/about August 17 and last approximately 14 days. Traffic will be maintained, expect delays.
