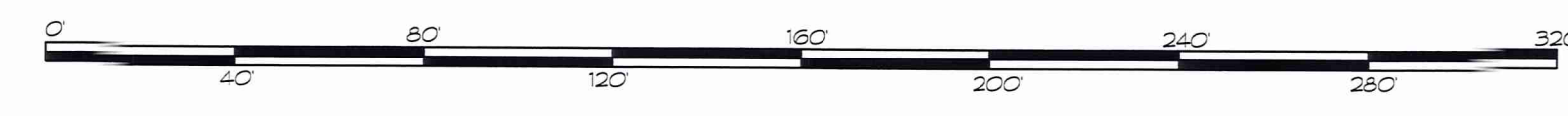

Situated in the Township of Auburn, County of Geauga and the State of Ohio, and known as part of Lot No. 14 in Tract No. 3 within said Township and further described as follows:

Beginning in the center line of Munn Road at a one inch iron pin found and used in a Monument Box at the intersection of said center line with the Southerly line of Auburn Township;

Thence N. 13° 42' 00" E. along said center line 1943.12 feet to a one inch iron pin in a Monument Box found and used at an angle in said center line;

Thence N. 13° 18' 25" E. continuing along said center line 1071.67 feet to the Southwesterly corner of land conveyed to Thomas J. and Susan L. Flute by deed recorded in Volume 841, Page 657 of the Geauga County Deed Records;

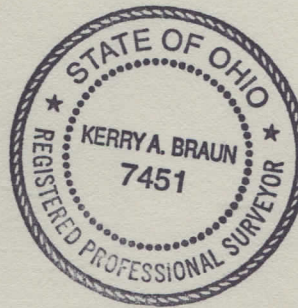

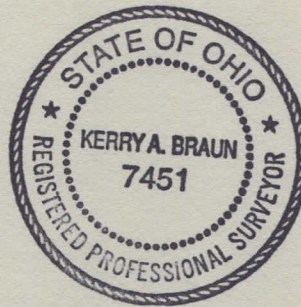
