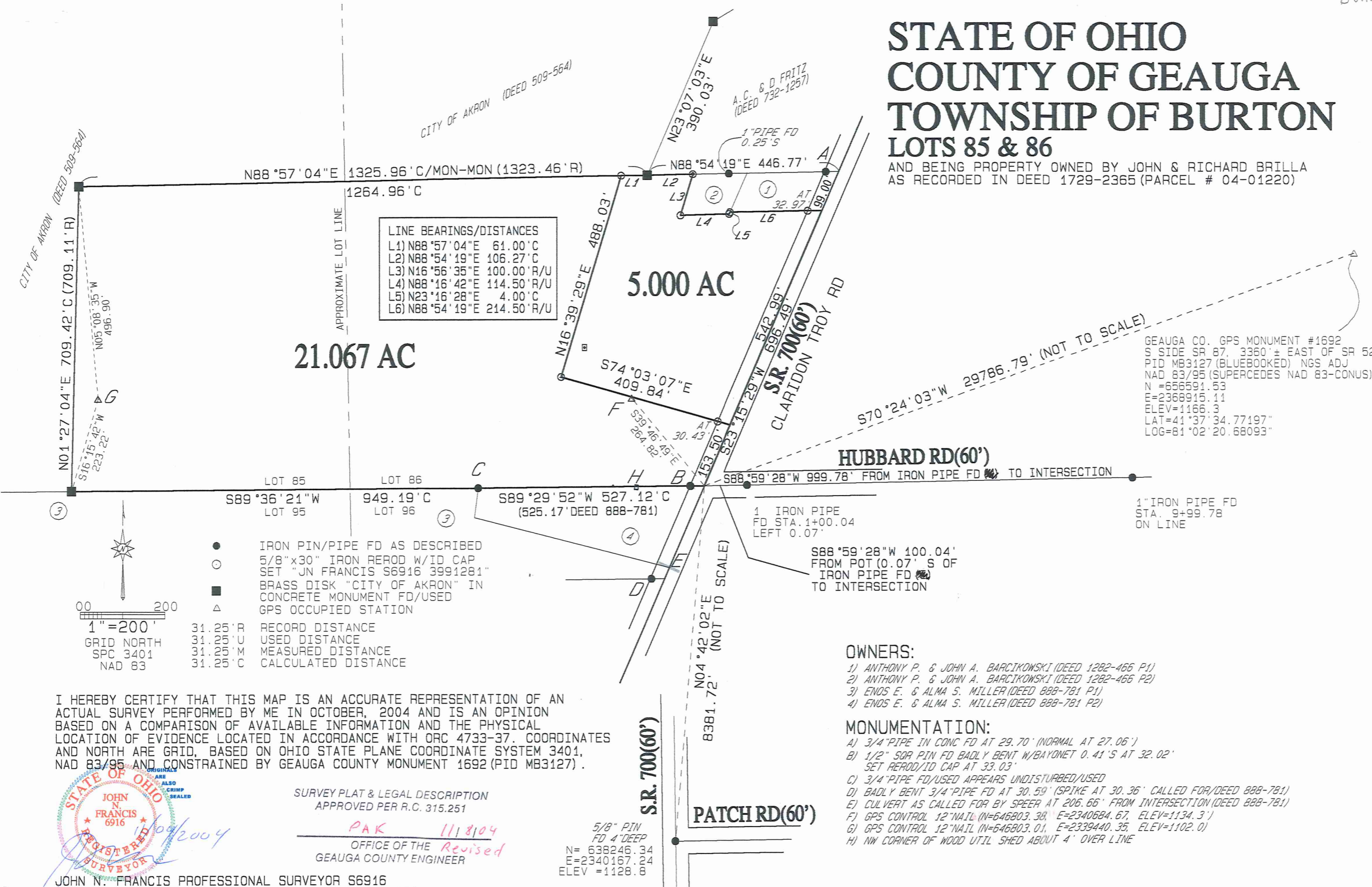

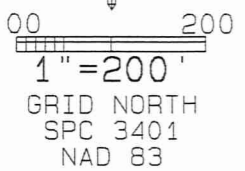

**SITUATED** in the State of Ohio, County of Geauga, Township of Burton, Lots 85 and 86 and being **5.000 acres** owned by John and Richard Brilla(Deed 1729-2365)

**BEGINNING** at the northeast corner of Enos E & Alma S. Miller(Deed 888-781) and the intersection of Hubbard Road(60') and S.R. 700/Claridon Troy Rd.(60') and bears South 70°24'03" West, 29786.79 feet from a Geauga County GPS monument(#1692/PID-MB3127, N=656591.53, E=2368915.11, Elev=1166.3(Nad 83/95), North 04°42'02" East, a distance of 8381.72 feet from a 5/8 inch iron pin found 4 inches deep at the intersection of Patch Road(60') and S.R. 700 and South 88°59'28" West, 100.04 feet from a point 0.07' south of a 1" iron pin found at Station 1+00.04 on Hubbard Road(60').

**THENCE North 23°15'29" East** and along the centerline of S.R. 700, a distance of 153.50 feet to the **TRUE PLACE OF BEGINNING** for the parcel being described,

**THENCE North 74°03'07" West**, through the lands of Brilla and passing through a 5/8 inch iron rered set at 30.43 feet, a distance of 409.84 feet to a 5/8 inch iron rered set;

**THENCE North 16°39'29" East** continuing through the lands of Brilla, a distance of 488.03 feet to a 5/8 inch iron rered set on the southerly line of the City of Akron (Deed 509-564);

**SITUATED** in the State of Ohio, County of Geauga, Township of Burton, Lots 85 and 86 and being **21.067 acres** owned by John and Richard Brilla (Deed 1729-2365)

**BEGINNING** at the northeast corner of Enos E & Alma S. Miller (Deed 888-781) and the intersection of Hubbard Road (60') and S.R. 700/Claridon Troy Rd. (60') and bears South 70°24'03" West, 29786.79 feet from a Geauga County GPS monument (#1692/PID-MB3127, N=656591.53, E=2368915.11, Elev=1166.3 (Nad 83/95), North 04°42'02" East, a distance of 8381.72 feet from a 5/8 inch iron pin found 4 inches deep at the intersection of Patch Road (60') and S.R. 700 and South 88°59'28" West, 100.04 feet from a point 0.07' south of a 1" iron pin found at Station 1+00.04 on Hubbard Road (60') and is the **TRUE PLACE OF BEGINNING** for the parcel being described.
