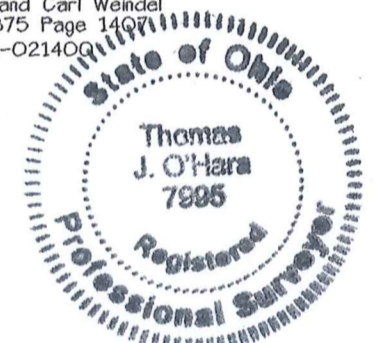

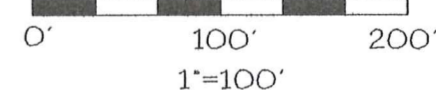

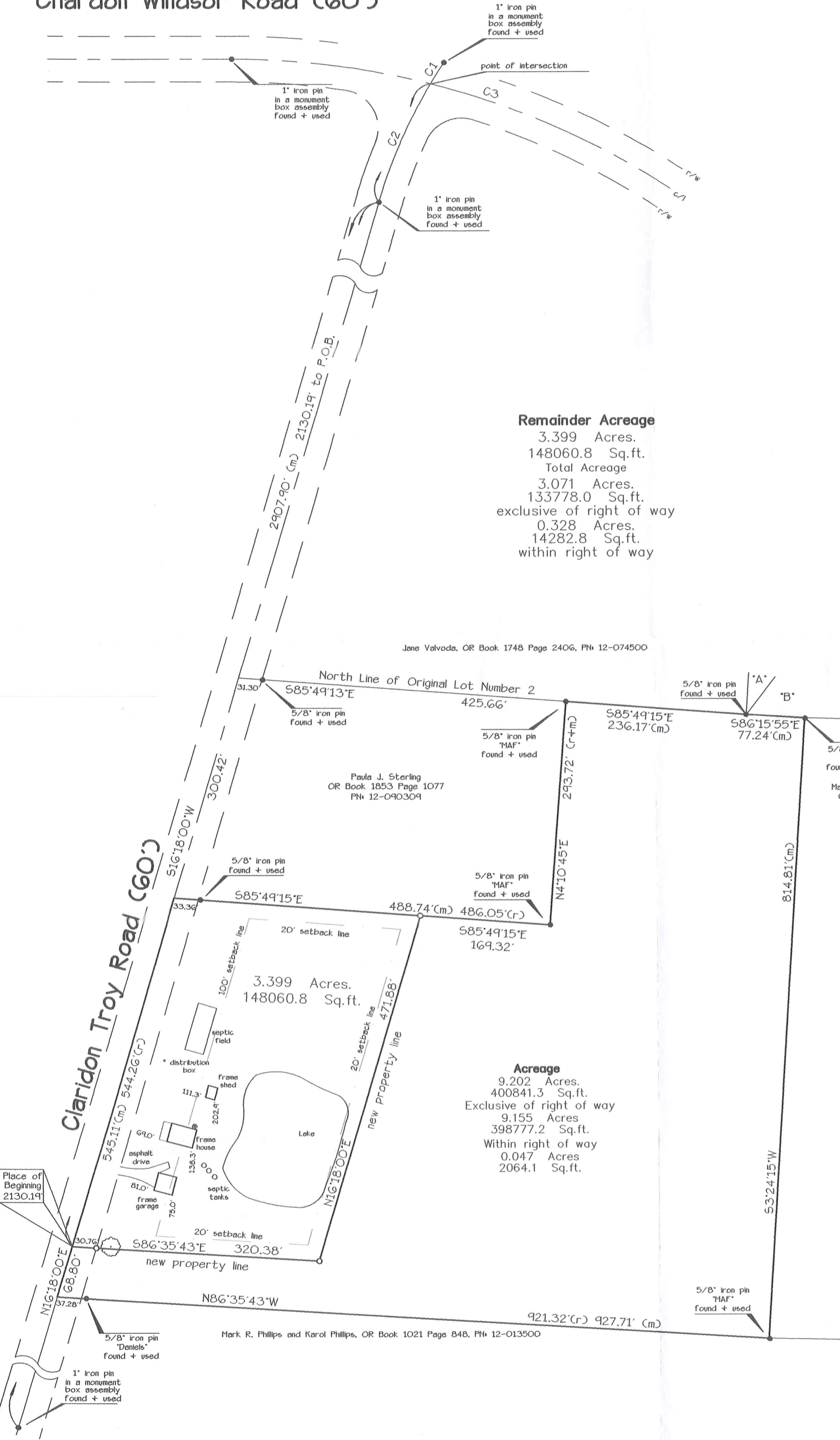

**Survey Split of Land now or formerly owned by
James Stouffer and Eileen Stouffer, PN: 12-024300, OR Book 1262 Page 441**

Situated in the Township of Claridon, County of Geauga, State of Ohio, being part of Section One, of the East Survey, part of Original Lot Number 2. Beginning at the centerline intersection of Chardon Windsor Road (60') and Claridon Troy Road (60'), said point witnessed by a 1" iron pin found in a monument box assembly, North 32°06'52" East a distance of 33.10 feet therefrom. Thence along the centerline of Claridon Troy Road following a curve deflecting to the left, having a radius of 674.07 feet, an arc distance of 169.50 feet, having a chord bearing South 23°30'13" West for a distance of 169.05 feet to a point, said point witnessed by a 1" iron pin found in a monument box assembly. Thence South 16°18'00" West along the centerline of Claridon Troy Road, a distance of 2130.19 feet to a point, said point being a new property corner established, said point being the **Place of Beginning** of the parcel herein described.

Thence **South 86°35'43" East** along a new property line created, passing through an iron pin set at 30.76 feet, a total distance of **320.38** feet to a point, said point being a new property corner established, said point witnessed by an iron pin set.

Thence **North 16°18'00" East** along a new property line created a distance of **471.88** feet to a point, said point being a new property corner established, said point being on the southerly line of land now or formerly owned by Paula J. Sterling, as recorded in OR Book 1853 Page 1077 in Geauga County Record of Deeds, (GCRD), said point witnessed by an iron pin set.

Thence **South 85°49'15" East** along the southerly line of land now or formerly owned by Sterling, aforementioned, a distance of **169.32** feet to a point, said point being the southeast corner of land now or formerly owned by Sterling, aforementioned, said point witnessed by a 5/8" iron pin "MAF" found.

Thence **North 04°10'45" East** along the easterly line of land now or formerly owned by Sterling, aforementioned, a distance of **293.72** feet to a point, said point being on the southerly line of land now or formerly owned by Jane Valvoda, PN: 12-074500, as recorded in OR Book 1748 Page 2406 in GCRD, said point witnessed by a 5/8" Iron Pin "MAF" found.

Thence **South 85°49'15" East** along the southerly line of land now or formerly owned by Valvoda, aforementioned, a distance of **236.17** to a point, said point being the south corner of land now or formerly owned by Robert L. Maxwell and Mary Jo, PN: 12-056500, as recorded in OR Book 921 Page 127 In GCRD and the southwest corner of land now or formerly owned by Pati Weindel and Carl Weindel, PN: 12-021400, as recorded in OR Book 1875 Page 1407, said point witnessed by a 5/8" iron pin found,

Thence **South 86°15'55" East** along the southerly line of land now or formerly owned by Weindel, aforementioned, a distance of **77.24** to a point, said point being the northwest corner of land now or formerly owned by Mark Phillips and Karol Phillips, PN: 12-090307, as recorded in OR Book 1262 Page 439 in GCRD, said point witnessed by a 5/8" iron pin "MAF" found.


Thence **South 03°24'15" West** along the westerly line of land now or formerly owned by Phillips, aforementioned, a distance of **814.81** to a point, said point being on the north line of land now or formerly owned by Mark R. and Karol Phillips, PN: 12-013500, as recorded in OR Book 1021 Page 848 in GCRD, said point witnessed by a 5/8" iron pin "MAF" found.

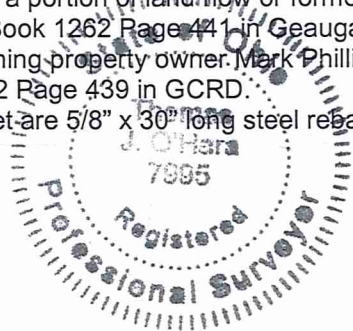
Thence **North 86°35'43" West** along a northerly line of land now or formerly owned by Phillips, aforementioned, a distance of **927.71** to a point in the centerline of Claridon Troy Road, passing through a 5/8" iron pin found "Daniels" at 37.28 feet therefrom

Thence **North 16°18'00" East** along the centerline of Claridon Troy Road, a distance of **68.80** feet to a point, Said point being the Place of Beginning, and containing **9.202 acres** total, 9.155 acres exclusive of right of way and 0.047 acres within the right of way, be the same more or less, but subject to all legal highways, pursuant to a Survey (1179) dated August, 2012, by O'Hara Land Surveying, L.L.C. and Thomas J. O'Hara, Ohio Registered Surveyor No. 7995.
