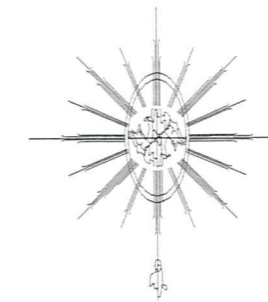

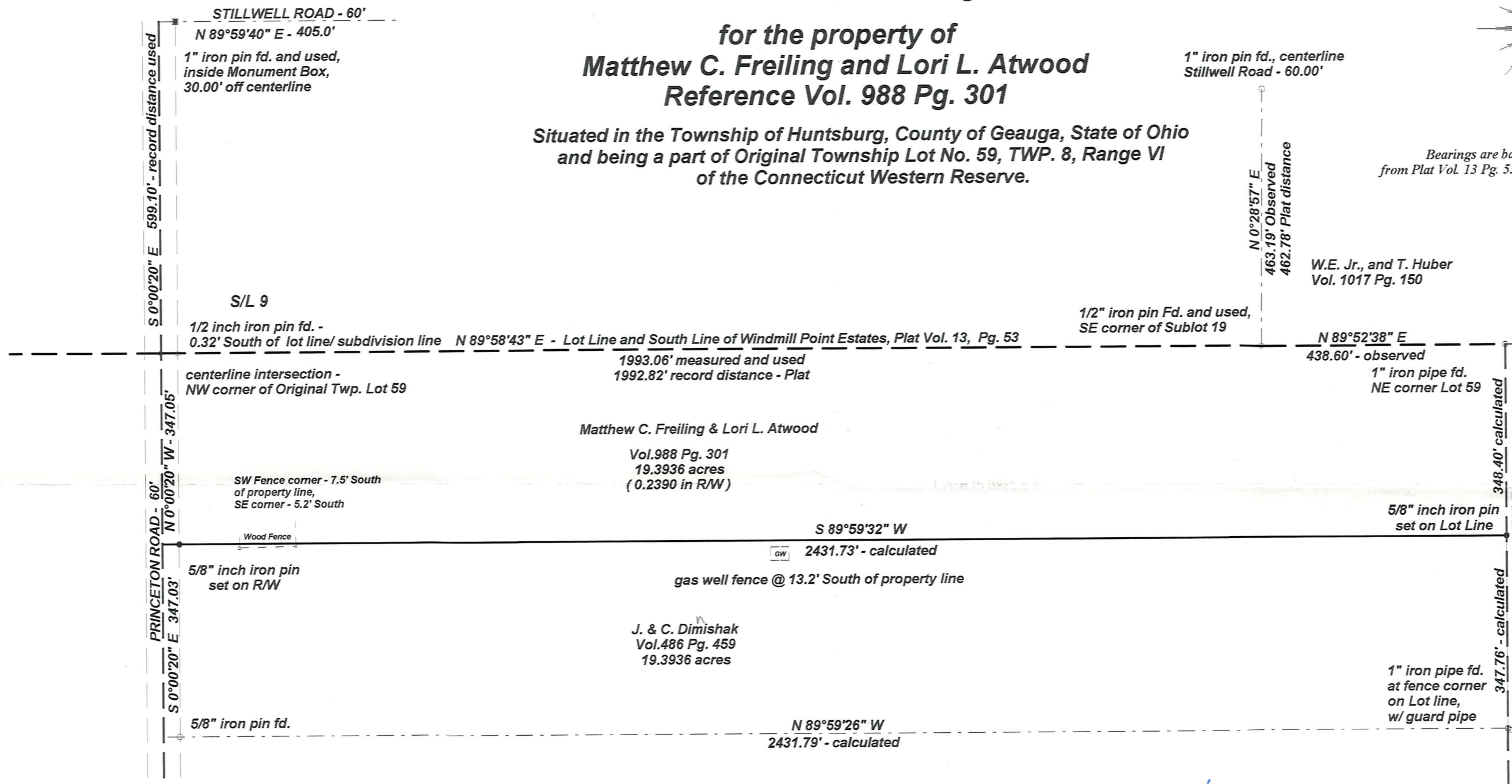

of the Connecticut Western Reserve.

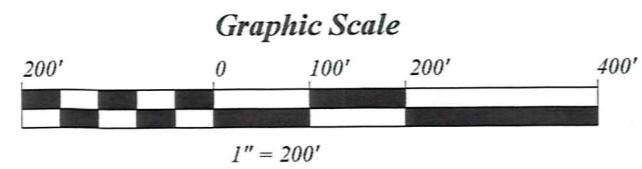

Description of Property for Matthew C. Freiling and Lori L. Atwood Reference Vol. 988 Pg. 301

Situate in the Township of Huntsburg, County of Geauga, and the State of Ohio, and known as being a part of Original Township Lot No. 59, TWP. 8, Range VI W, of the Connecticut Western Reserve, further bounded and described as follows:

Beginning at a point at the intersection of Princeton Road, 60 feet in width, and Stillwell Road, 60 feet in width, said point being S 89°59'40" W, a distance of 30.00 feet from an one inch iron pin found inside a monument box, as recorded in Plat Vol. 13 Pg. 53, of the Geauga County Record of Plats, known as Windmill Point Estates Subdivision, thence S 00°00'20" E, along the centerline of said Princeton Road, a distance of 599.10 feet to a point at the Northwest corner of Original Lot 59, and the Southwest corner of Sublot 9 of said Windmill Point Estates, said point being
The Principle Point of Beginning:

Course No. 1: Thence N 89°58'43" E, along the North line of Original Lot 59, and the South line of said Windmill Point Estates, passing through an one half inch iron pin found 0.32 feet South, a distance of 30.00 feet, a total distance of 1993.06 feet to an one half inch iron pin found at the Southeast corner of Sublot 19 of said Windmill Point Estates, and the Southwest corner of W.E. Jr. And T. Huber, as recorded in Vol. 1017 Pg. 150 of the Geauga County Official Records;

Course No. 2: Thence N 89°52'38" E, along the said lot line and the South line of said Huber land, a distance of 438.60 feet to an one inch iron pipe found at the Northeast corner of said lot 59, and the Northwest corner of R.E. and S.L. West, as recorded in Vol. 989 Pg. 779 of the Geauga County Official Records;

Course No. 3: Thence S 00°00'58" E along the East line of said lot 59, and the West line of said R.E. and S.L. West land, a distance of 348.40 feet to a 5/8 inch iron pin set w/ I.D. cap at the Northeast corner of J. and C. Dimishak, as recorded in Vol. 486 Pg. 459 of the Geauga County Record of Deeds;

Course No. 4: Thence S 89°59'32" W, along the northerly line of said Dimishak land, passing through a 5/8 inch iron pin set w/ I.D. cap at 2401.73 feet, a total distance of 2431.73 feet to a point in the centerline of said Princeton Road;

Course No. 5: Thence N 00°00'20" W, along the centerline of said Princeton Road, a distance of 347.05 feet to **The Principle Point of Beginning**, containing 19.3936 acres of land of which 0.2390 acre is within the right of way, and subject to all highways and easements.
