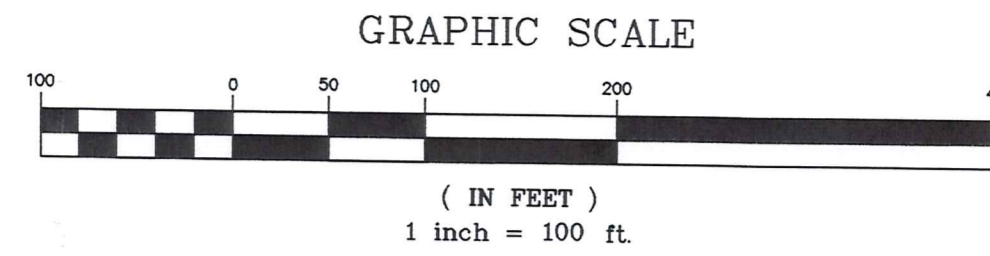
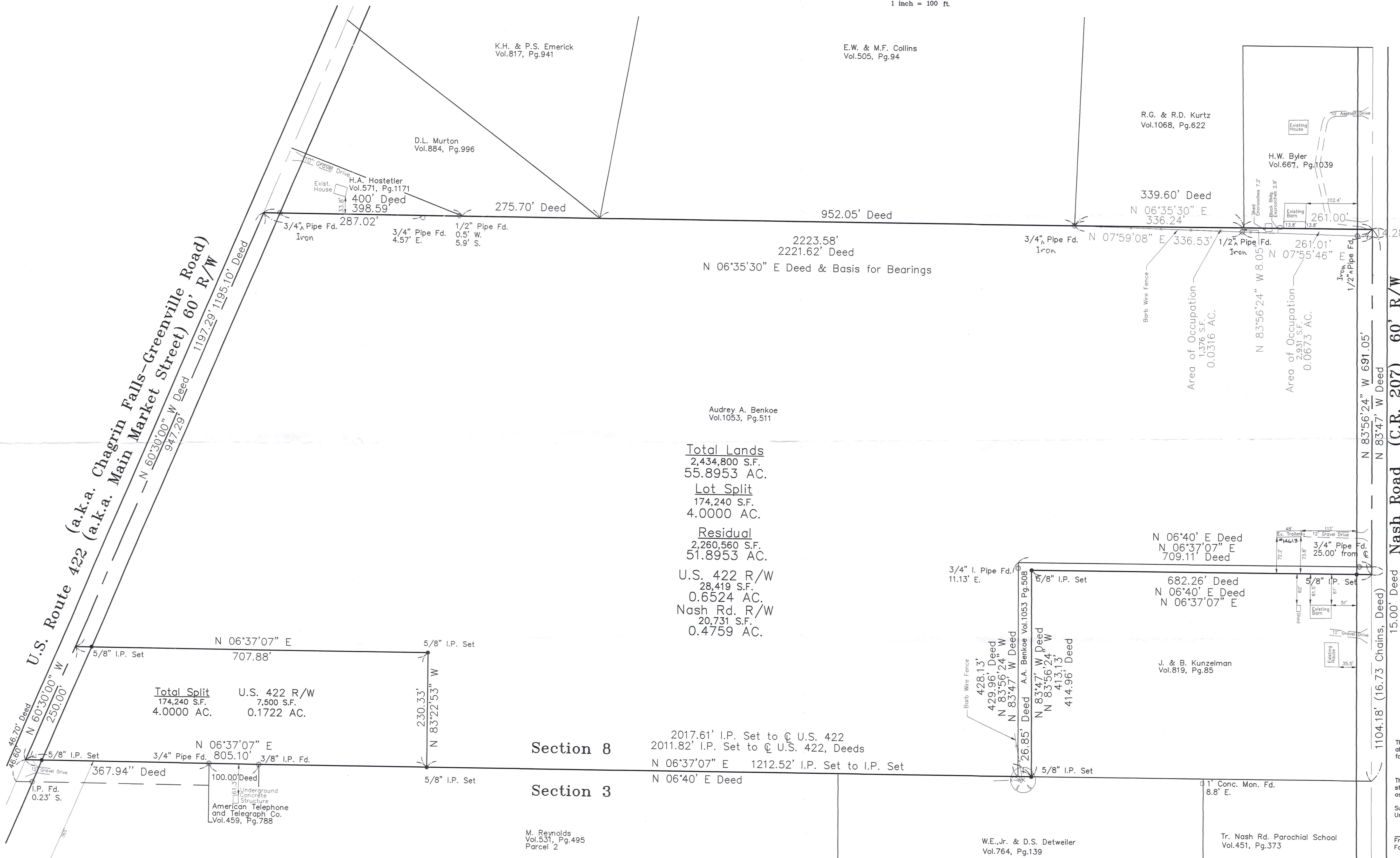

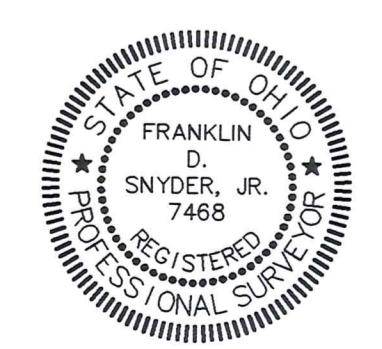

Description of 51.8953 Acres

Situated in Section 8 of Troy Township, Geauga County, Ohio and known as being part of Township 6, Range 7 in the Connecticut Western Reserve and further described as follows:

Beginning on the centerline of U.S. Route 422 (60' feet wide), North 60°30'00" West, 250.00 feet from the intersection of said centerline with the easterly line of Section 8 of Troy Township;

- COURSE I Thence along the centerline of U.S. Route 422, North 60°30'00" West, 947.29 feet to the southeasterly corner of lands deeded to Helen Alice Hostetler in volume 571, page 1171, Geauga County Deed Records;
- COURSE II Thence along the easterly line of Hostetler's lands, and the easterly lines of lands deeded to Deborah L. Murton in volume 884, page 996, Geauga County Deed Records, Eugene W. and Marlene F. Collins in volume 505, page 94, Geauga County Deed Records, Robert G. and Rosanna D. Kurtz in volume 1068, page 622, and Harvey W. Byler in volume 667, page 1039, Geauga County Deed Records, North 6°35'30" East, at 32.57 feet passing through a 3/4" iron pipe found at the northerly right of way line of U.S. Route 422, at 1626.34 feet passing through a 3/4" iron pipe found at Eugene W. and Marlene F. Collins' northeasterly corner, at 1962.58 feet passing 8.05 feet westerly from a 1/2" iron pipe found, at 2193.58 feet passing 13.58 feet westerly from a 1/2" iron pipe found at the southerly right of way line of Nash Road, 2223.58 feet to the centerline of Nash Road, 60 feet wide;
