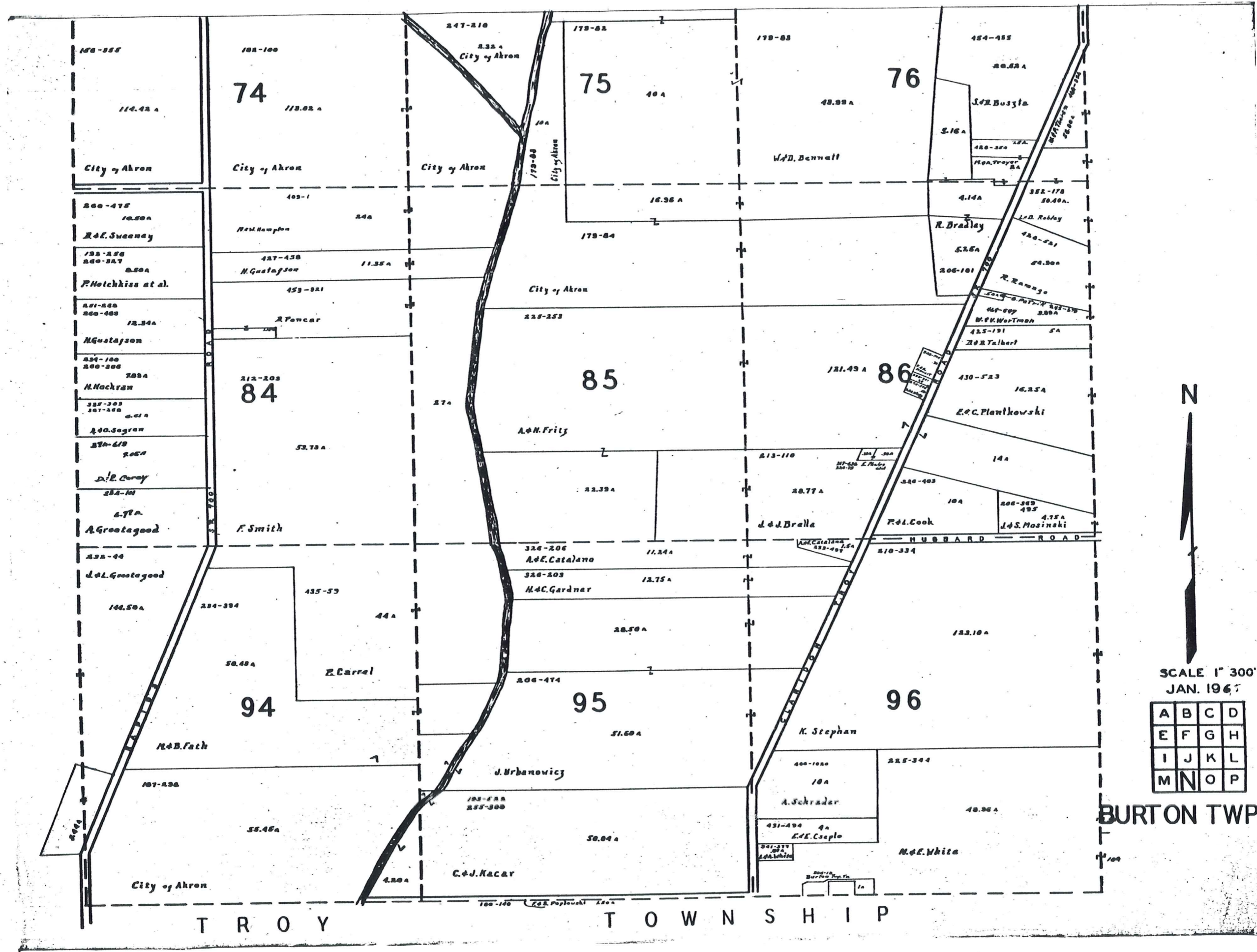

T R O Y T O W N S H I P

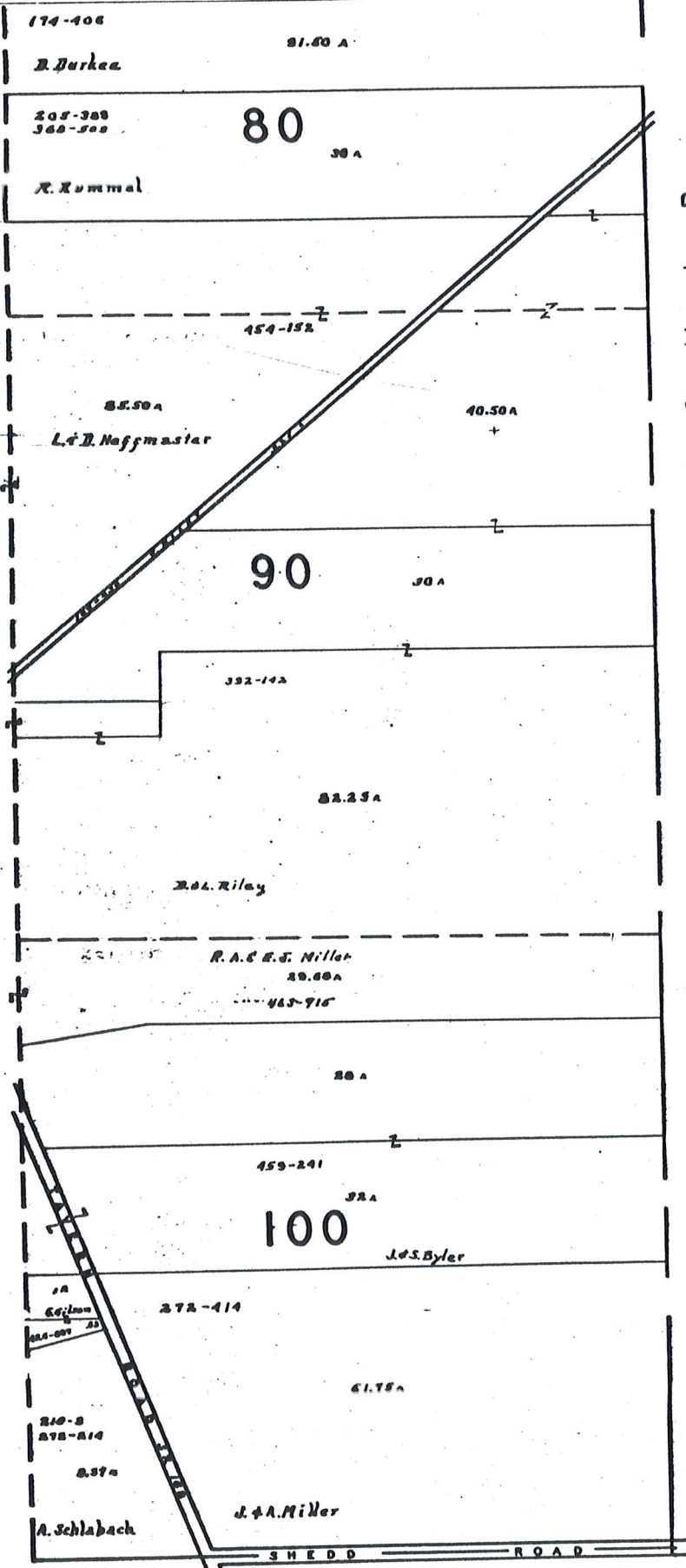

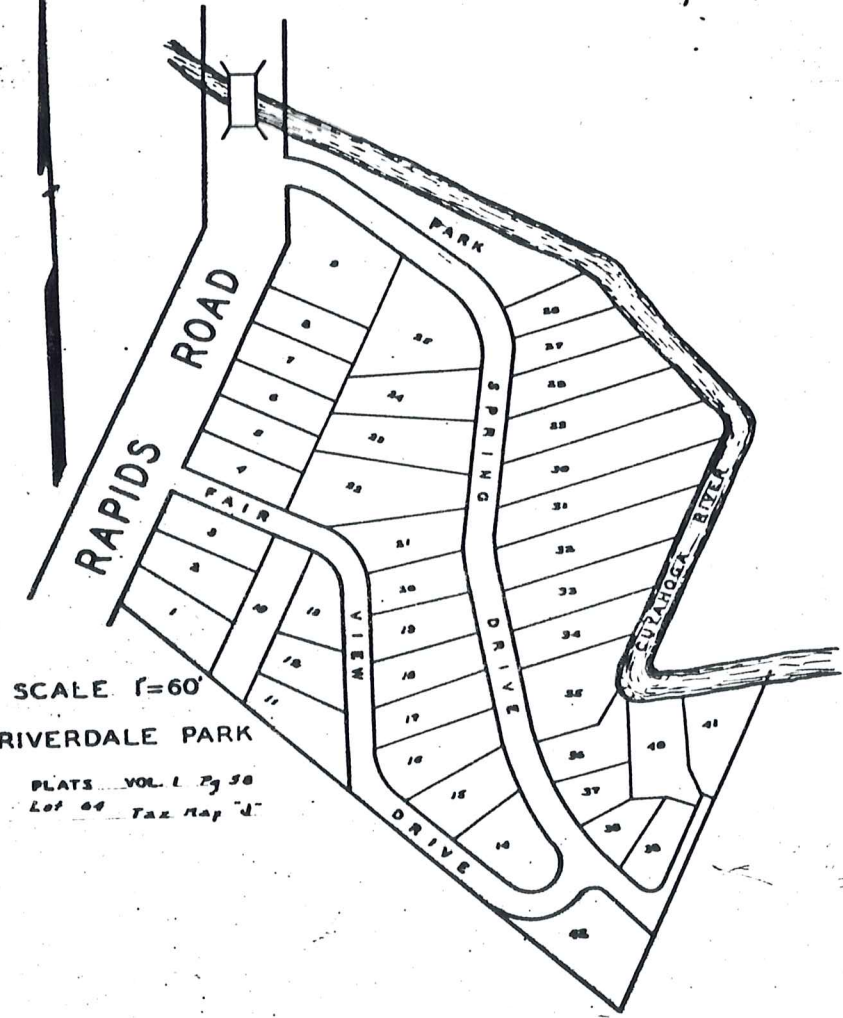

 PLATS VOL. I - PG. 52



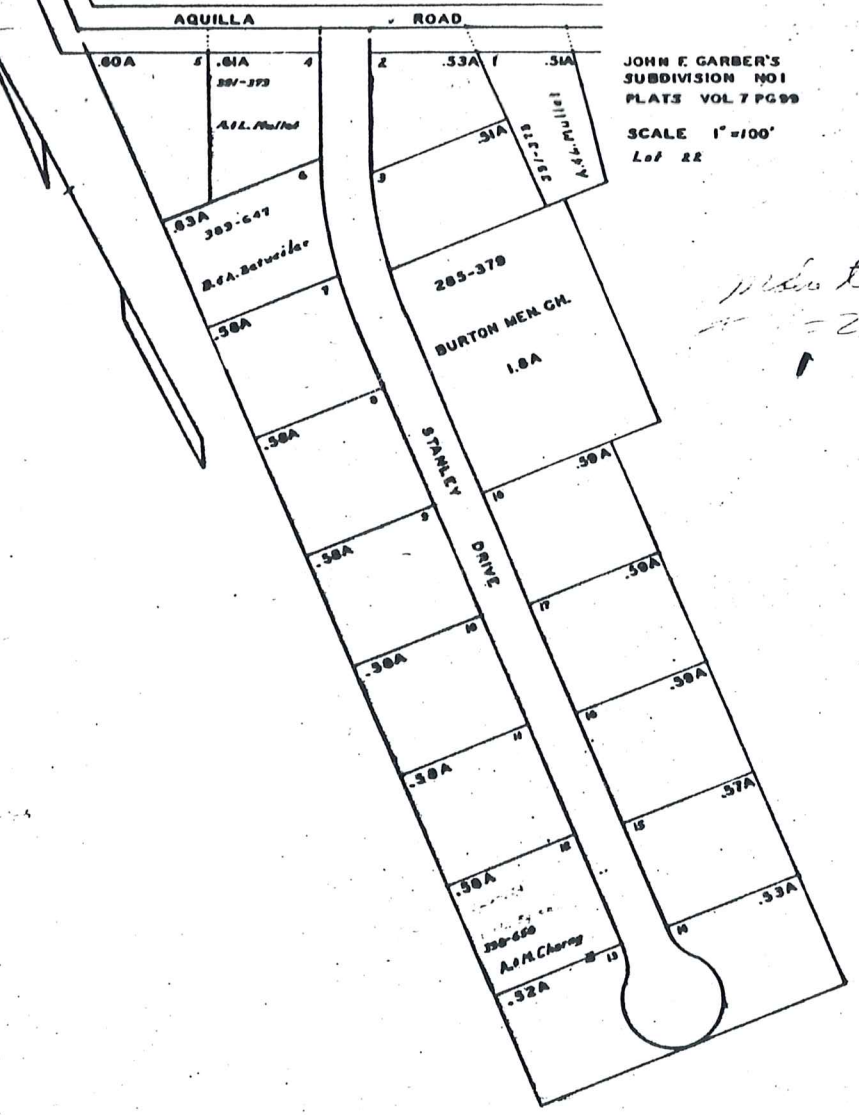

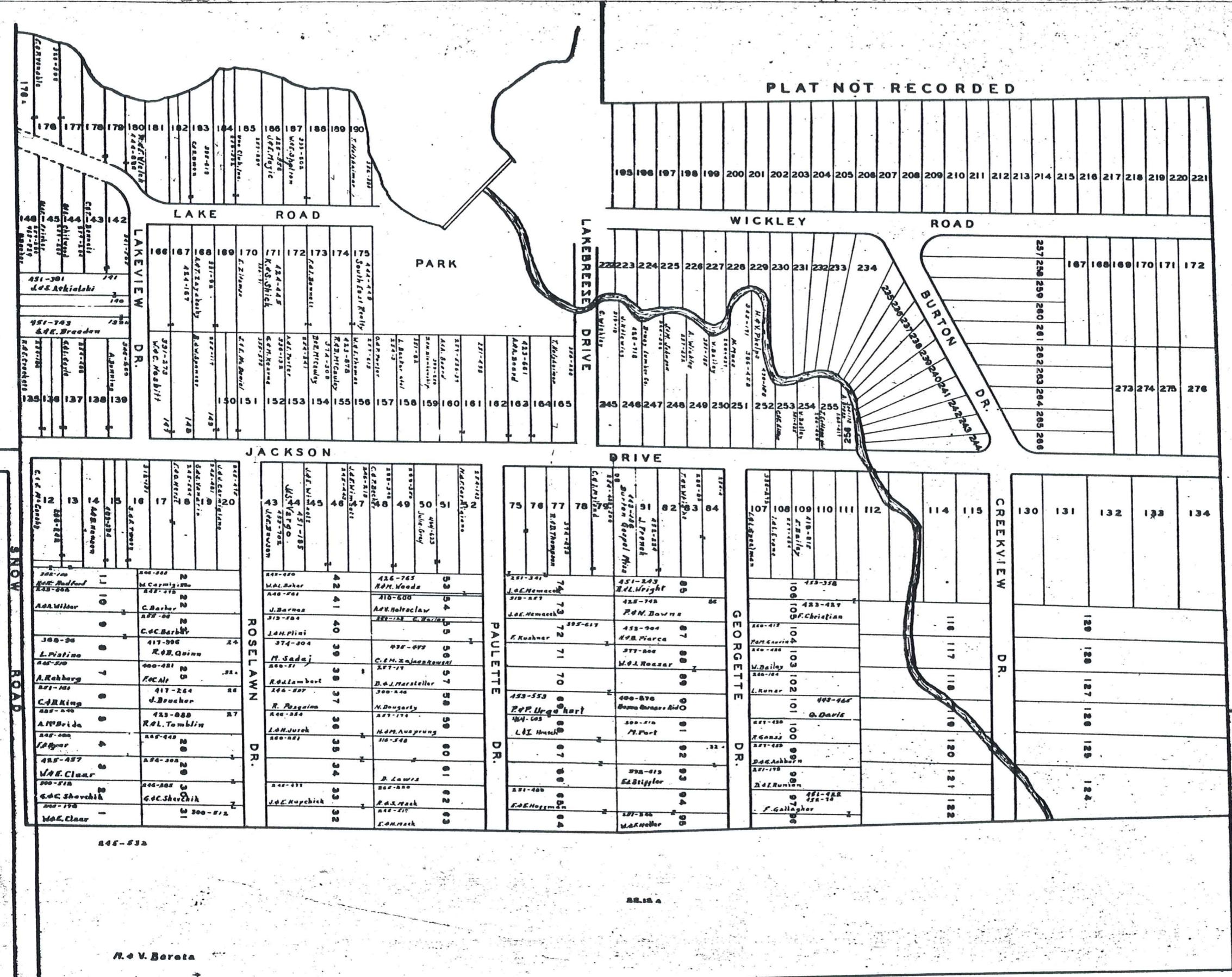
