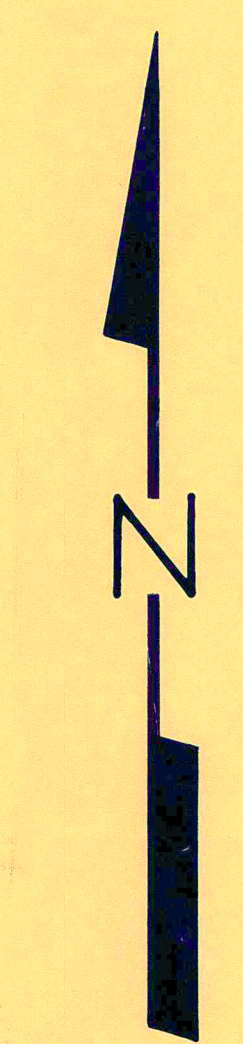
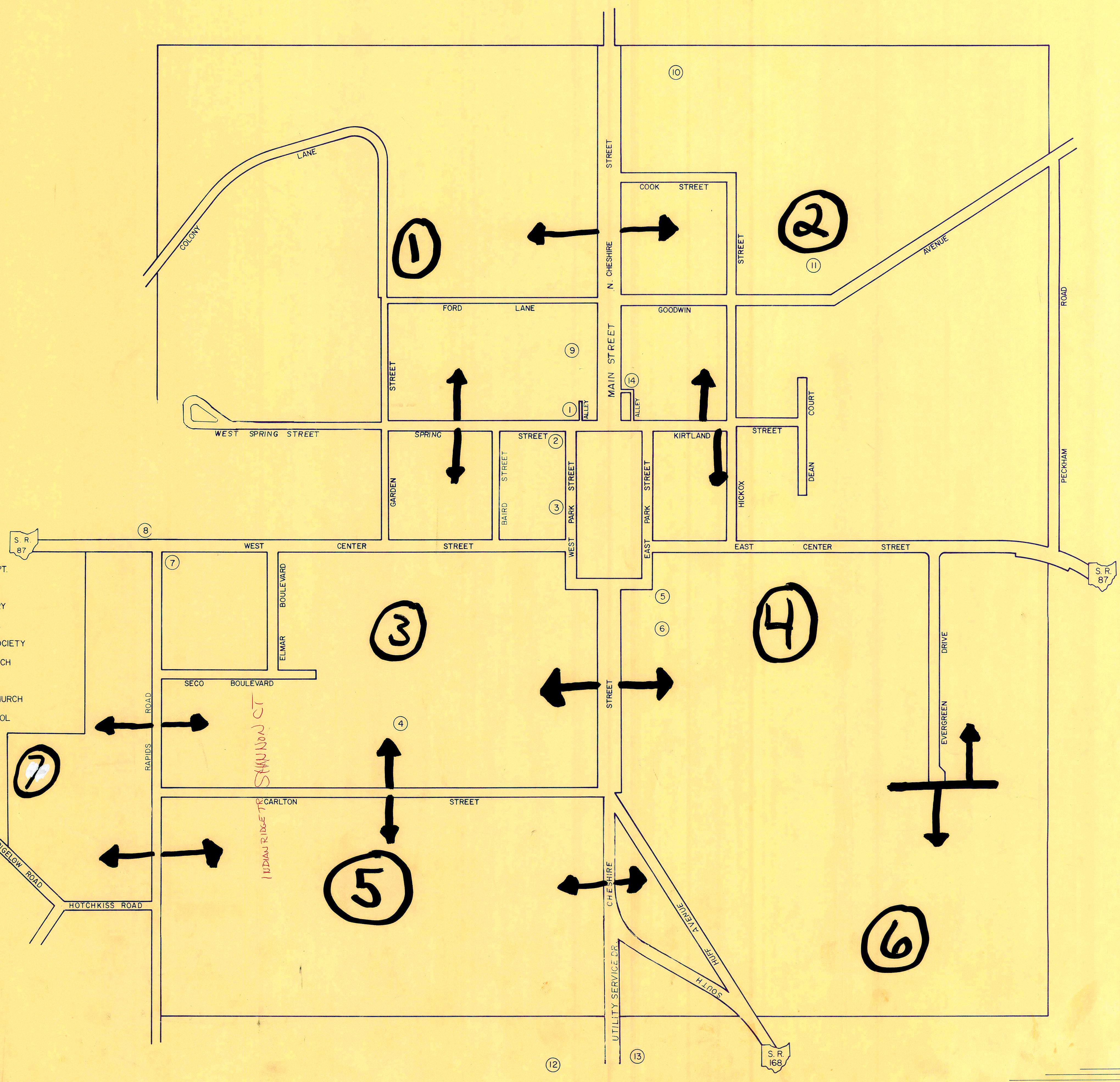


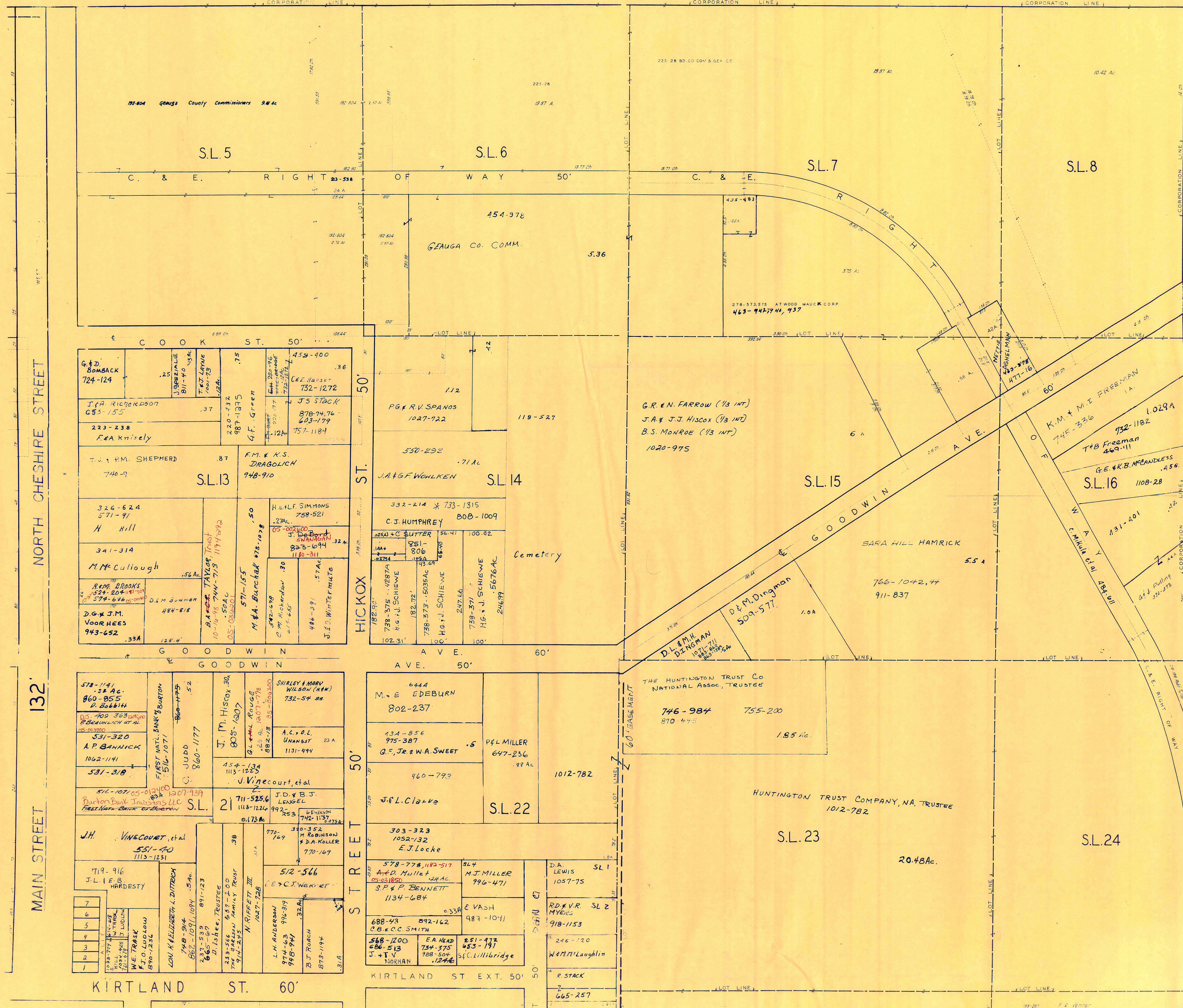
MAP OF BURTON VILLAGE



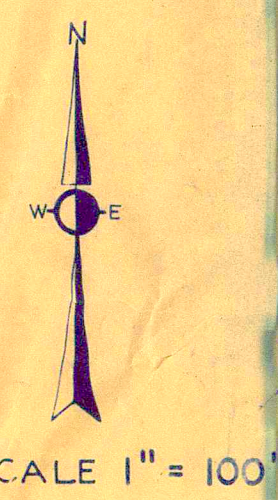

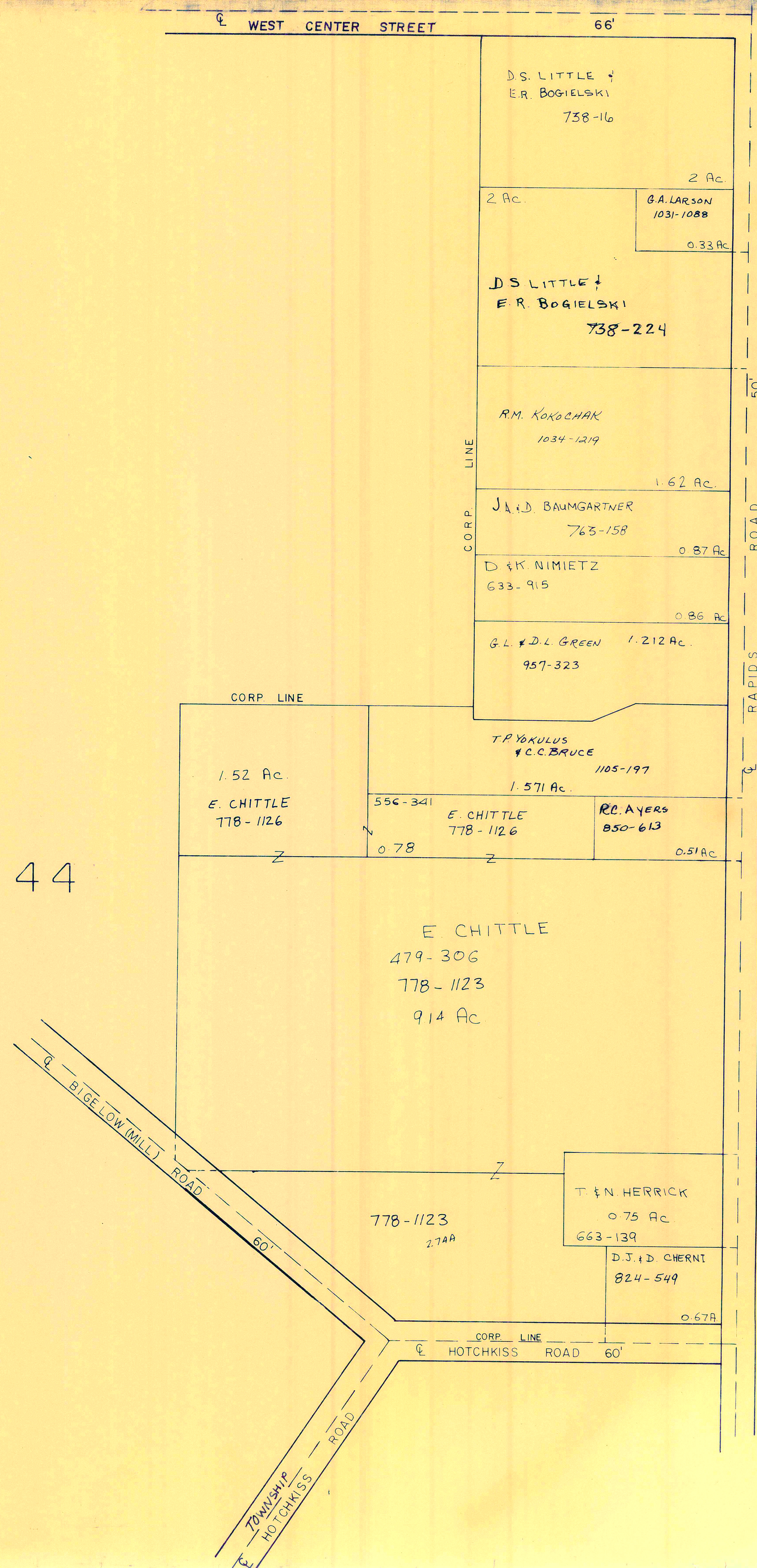
